

ORDINANCE NO. 18-O-03
AN ORDINANCE ADOPTING PREVAILING WAGE RATES
TO BE PAID TO LABORERS, MECHANICS AND OTHER WORKERS
PERFORMING CONSTRUCTION OF PUBLIC WORKS
EMPLOYED BY THE TINLEY PARK-PARK DISTRICT

WHEREAS, the State of Illinois has enacted the Prevailing Wage Act, regulating wages of laborers, mechanics and other workers employed in any public works by the State, County, City or any public body or any political subdivision or by anyone under contract for public works”, approved June 26, 1941, as amended, being Chapter 820 ILCS 130/1-12, Illinois Compiled Statutes; and

WHEREAS, the aforesaid Act requires that the Tinley Park-Park District investigate and ascertain the prevailing rate of wages as defined in said Act for laborers, mechanics and other workers in the locality of said Tinley Park-Park District employed in performing construction of public works, for said (public body); and

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF COMMISSIONERS OF THE TINLEY PARK-PARK DISTRICT, COOK COUNTY, ILLINOIS, as follows:

SECTION 1

To the extent and as required by “An Act regulating wages of laborers, mechanics and other workers employed in any public works by the State, County, City or any public body or any political subdivision or by anyone under contract for public works” approved June 26, 1941, as amended, the general prevailing rate of wages in this locality for laborers, mechanics and other workers engaged in the construction of public works coming under the jurisdiction of this Tinley Park-Park District is hereby ascertained to be the same as the prevailing rate of wages for construction work in the Cook and Will County area as determined by the Department of Labor of the State of Illinois as of June 2018, a copy of that determination being attached hereto as Exhibit “A” and incorporated herein by reference. The definition of any terms appearing in this Ordinance which area also used in the aforesaid Act shall be the same as in said Act.

SECTION 2

Nothing herein shall be construed to apply said general prevailing rate of wages as herein ascertained to any work or employment except public works of this Tinley Park-Park District to the extent required by the aforesaid Act.

SECTION 3

The Secretary shall publicly post or keep available for inspection by any interested party in the main office of this Tinley Park-Park District this determination of such prevailing rate of wage.

SECTION 4

The Secretary shall mail a copy of this determination to any employer, and to any association of employers and to any person or association of employees who have filed, or file their names and addresses, requesting copies of any determination stating the particular rates and the particular class of workers whose wages will be affected by such rates.

SECTION 5

The Tinley Park-Park District shall promptly file a certified copy of this Ordinance with Department of Labor of the State of Illinois.

SECTION 6

The Park District shall within 30 days of the filing provided for in Section 5 above, cause a notice of is determination of prevailing wages to be placed on the Park District's website with a hyperlink directly to the prevailing wage schedules for Cook and Will Counties that are published on the official website of the Illinois Department of Labor. Said notice shall conform substantially to the notice attached hereto as Exhibit "B" and incorporated herein by reference. Such publication shall constitute notice that this is the determination of the Tinley Park-Park District and is effective.

SECTION 7

In all Park District public works construction contracts or other written instruments, there shall be inserted a written stipulation that the prevailing rate of wages are revised by the Department of Labor and are available on the Department's official website.


