Specifically, the Governor's Order: (1) suspends the requirement in Section 2.01 that "members of a public body must be physically present;" and (2) suspends the limitations in Section 7 on when remote participation is allowed. On April 30, 2020, Executive Order 2020-33 re-issued Executive Order 2020-07. Executive Director Shawn Roby confirmed Board Members and Staff were able to communicate. All replied affirmative. Executive Director Shawn Roby then introduced ground rules for effective and clear conduct of Park District business.
