Resolution 22-R-45 Financial Audit

Resolution 22-R-47 Purchase Policy Update

The State of Illinois has moved the bid threshold for park districts up to match that of municipal governments to \$30,000. Our current threshold of \$25,000 is approved by board action and in order to move up the board would need to again approve an updated purchase policy.

Along with the update bid threshold included will be an increase to the directors purchase ability from \$5,000 to \$7,500 which will help us with inflation items that would normally not need to be bought to the board.

Resolution 22-R-48 Cardio Equipment Purchase

Tinley Fitness Management staff worked with Direct Fitness Solutions on purchasing new cardio equipment.

Resolution 22-R-49 Lease Agreement of Cardio Equipment

The new cardio equipment we are recommending from Direct Fitness for purchase will be leased through NCL Government Capital for 36 months.

Resolution 22-R-50 Design Services

Staff is recommending we approve an agreement with Design Perspectives to take advantage of the new round of OSLAD to improve Community Park amenities.
