The attorney reminded everyone that the district can still make this the economic engine and has a variety of options.

Park District is going to create a website to inform residents of progress on the Mental Health site.

Park District is going to create a remediation committee led by Commissioner Lisa O'Donovan to make sure the public interests are being heard.

Conclusion/Goal is that taxpayers are going to pay 0\$ to clean up eye sore.

Once the site is cleaned up this site should become an economic engine for Tinley Park.
